IMPORTANT DATES

- ◆ All work will be juried by the Fullerton College Art Department faculty.
- ◆ All work must have been completed in a Fullerton College art class during the past year.
- ◆ Students must **completely** fill out one form for each entry, limit 4. \$5 submission fee per entry.
- ◆ All 3-D works must have a stable base or flat bottom.
- ◆ All 2-D works must be ready to hang: no wet work, charcoal must be fixed, indicate top of work if it is unclear, no sawtooth hanging clips.
- ◆ Students must drop off and pick up work during specified periods (indicated to the right).
- ◆ Any student who does not pick up their work by the required deadlines forfeit their work to the gallery. Unclaimed works will become the property of the gallery, who reserves the right to keep, store, donate, sell or dispose of artwork as it sees fit.
- ◆ Student agrees that if a work is sold as a result of the exhibition, the gallery will retain a 30% commission of the total sale amount (25% going to the Gallery Fund and 5% going to the Fine Arts Scholarship Fund). 70% of the sale price will be paid to the artist via check by the FC bursar.
